

## Terms of Service

CodeSavanna.org (“Code Savanna”, “we”, “us”, or “our”) is dedicated to upholding your privacy rights. This Privacy Policy elucidates our practices concerning the collection, utilization, and disclosure of information that you (“you” or “user”) may furnish to us through your engagement with our website at codesavanna.org and all its sub-domains (collectively, the “Site”), the Application Portal accessible via the Site (the “Application Portal”), and our social media platforms, pages, and other applications, encompassing any content, functionality, products, services, or communications provided or occurring on or through any of those mentioned above (collectively, the “Services”).

By accessing, registering for, visiting, and/or utilizing our Services, you agree to be bound by this Privacy Policy and our Terms of Service. If you do not consent to the terms of this Privacy Policy AND OUR TERMS OF SERVICE, kindly refrain from VISITING, REGISTERING FOR, ACCESSING, AND/OR utilizing the Services. The current versions of this Privacy Policy AND OUR TERMS OF SERVICE shall govern each instance of using the Services.

### **INFORMATION WE COLLECT**

We collect two primary types of information from users of our Services: “Personal Information,” which can identify you (such as your name or email address), and “Aggregate Information,” which cannot identify you (such as visit frequency to the Site or browser type).

### **INFORMATION YOU PROVIDE TO US**

We collect Personal Information voluntarily submitted by you when using our Services, such as during account registration (as detailed below) or through the submission of online forms via our Site using the Contact page. For instance, you may provide your name, email address, company name, communication content, or other Personal Information via email, online forms, or similar means. Subscribing to our mailing list on our Contact Page entails providing us with pertinent information, thereby opting in to receive marketing and other communications from us. Interactions with us on social media may also result in the collection of your social media profile information, communications with us, and your posts on our social media pages.

### **REGISTRATION INFORMATION**

To access many of our Services and the Application Portal, completion of our registration process and creation of a username and password are requisite (as delineated in our Terms of Service). During registration, you must furnish Personal Information such as first and last name, date of birth, phone number, email address, and social media particulars. Additionally, we gather information regarding your college or university, course interests, equipment capabilities, and coding and technical proficiency.

### **DONATIONS**

We work with a third-party payment processor called Stripe, Inc., to process donations made to Code Savanna through the Site. Your bank account and/or credit or debit card information is never shared with us, and at no point in any donation transaction do we have access to that information. ## **YOUR COMMUNICATION WITH US**

We collect information from your communications with us, contingent upon the forum through which you engage with us. For instance, emailing us results in the collection of your email address and the email content.

## **INFORMATION WE AUTOMATICALLY COLLECT**

When utilizing our Site and Application Portal, we automatically receive and collect information from your device. This includes details such as device information, operating system, hardware, system version, Internet Protocol (IP) address, device ID, device language, country and general location, time zone, language used, specific actions undertaken on our Site and/or Application Portal, time, frequency, connection type, duration of use, interaction with email messages, identifiers associated with cookies or other technologies, and pages visited before or after navigating to our Site.

## **AGGREGATE INFORMATION COLLECTED**

Aggregate information, that does not identify you, may be gathered during your utilization of our Services, irrespective of any voluntarily entered information. Moreover, we may utilize processes to de-identify Personal Information-containing information, retaining solely aggregate information. Aggregate information may be collected, utilized, stored, and transferred without restriction (subject to applicable law).

## **COOKIES AND ANALYTICS**

Presently, we do not employ recognition cookies on our Site or Application Portal. However, we may utilize third-party services, such as Google Analytics, to analyze traffic to our Site and Application Portal. Google Analytics does not establish individual visitor profiles and solely aggregates data.
